



## CWWA President's Corner

It is hard to believe that it is already spring and the Joint Annual Meeting is just around the corner. It has been a busy year for CWWA. We have taken great strides toward the implementation of our Strategic Plan and are in the process of revamping our website to make it more useful to our members. A members-only page has been added to provide our members with timely information about new and pending laws and regulations, testimony and alerts on key legislative issues and electronic access to newsletters and Board minutes. We have also nearly completed updating our Constitution and By-Laws with the help of some of our past CWWA presidents.



It has been a busy Legislative Session so far and many CWWA members have been hard at work reviewing legislation, providing input on proposed bills and working with Betsy Gara, our Executive Director, to formulate effective testimony in support of or in opposition to the many bills that affect water utilities. These issues include:

**SB-365** - Requires operators of registered diversions to pay a fee set by the DEP commissioner; requires information regarding water diversions to be reported to DEP; establishes a water diversion account administered by the Water Planning Council; and requires DEP to adopt regulations relating to retiring water diversions and requires diversion operators to submit release data to DEP.

**SB-367** - Requires that the Water Planning Council develop and approve a long-range statewide water resource plan and oversee water resource planning and allocation on a comprehensive statewide basis.

**SB-371** - Requires that 90% of any buildable portion of class III land and 100% of any class II land be set aside for open space or recreational purposes in order for DPUC to allocate the proceeds of the sale substantially in favor of the water company's shareholders.

**SB-377** - Allows Class B and Class C investor-owned water companies to impose a surcharge on customers' bills to offset costs associated with infrastructure replacement.

**SB-462** - Allows courts to determine that an environmental law or regulation is obsolete or otherwise fails to protect the natural resource, thereby exposing companies to liability even if they are in full compliance with the law or regulation.

**SB-465** - Prohibits the state Department of Public Health from approving an abandonment of a well or reservoir if such supply is needed by another system in the state regardless of whether it is viable for another system to use the supply.

**HB-5235** - Provides a practical solution for the regulation and management of residuals re-use by providing that residuals blending and re-use be regulated under the existing General Permit for the Discharge of Water Treatment Wastewater through submittal of an Operations Plan.

**HB-5237** - Imposes fees of up to \$10,000 per registration per year on operators of registered diversions; imposes impractical metering requirements by requiring the installation of a totalizing flow meter on all registered

## Proposals Sought by The AWWA Research Foundation

The AWWA Research Foundation announced on February 25 that proposals are being requested for 21 research projects scheduled to be launched this year. The projects, with more than \$6 million in funding available, focus on a wide range of topics related to the drinking water community.

The projects are categorized into the Foundation's four strategic goal areas: efficient and customer-responsive organization, environmental leadership, high-quality water, and infrastructure reliability. The topics selected for study in 2004 reflect those that Foundation subscribers and others in the water supply community say are their most challenging.

Proposals submitted in response to an RFP must be postmarked by either May 7 or July 15, as specified in each RFP. All projects, unless otherwise indicated, must include 25 percent of the total project budget as in-kind or cash contribution. For each project, an appointed project advisory committee will evaluate proposals based on responsiveness to the RFP, scientific and technical merit, and qualifications of the researchers.



## Aquifer Protection Regulations Approved

Final approval was given to the long-awaited aquifer protection regulations. The regulations, effective 2/2/04, provide the minimum standard for land use regulations to be adopted by each municipality within which an Aquifer Protection Area is located. The regulations prohibit development of new high-risk land use activities that use hazardous materials and will require existing high-risk land use activities that use hazardous materials to register and adhere to best management practices.

Water companies are required to map, using methods specified in mapping regulations, the critical portions of the aquifer that provide water to the well fields. The preliminary (Level B) mapping has been completed for all the well fields, providing a general estimate of the critical areas.

This preliminary mapping will be refined by the water companies using extensive, site-specific data and ground-water modeling to determine the final (Level A) mapping area. The final mapping will define the regulatory boundaries for the land use regulations. A technical change to the existing mapping regulations is currently being considered. The first step in implementing the program will be for affected municipalities to appoint an existing board or commission to be the aquifer protection agency. A notification and information package detailing next steps and providing guidance to the affected municipalities is now available.

## Annual AWWA Legislative Fly-In

On April 21 and 22, the AWWA Government Affairs Office will be sponsoring its annual Fly-In in Washington, DC. Section representatives from around the country will be meeting with their Congressional Representatives and Senators to discuss issues of importance to the water industry that will be debated in Congress this year. These issues include drinking water infrastructure funding, water system security, source protection and MTBE.

This year, the CT Section will be represented by Tom Chaplik (Residuals Committee Chair and Board Trustee at Large) and John Herlihy, (Board Water Utility Council Chair).

Tom Curtis, AWWA Deputy Executive Director for Government Affairs, noted that last year's Fly-In was effective. "Shortly after the Fly-In, congressional offices began calling our Fly-In delegates and our office when they had questions on our issues," he said. "It particularly paid off when debates about the energy bill got hot and heavy." 

## Connecticut Water Company tops DPUC Scorecard for Water Utilities

The State of Connecticut Department of Public Utility Control (DPUC) announced in March that Connecticut Water Company had the best rating in the Department's Consumer Service Complaint Scorecard for water utilities for the second straight year. Connecticut Water ranked second overall out of all 40 utilities rated in 2003 including cable, telecommunications, electric, and natural gas utilities.
